Sanction Explanation

Education: Requirement to host an educational workshop on a specific topic to particular group (i.e. chapter membership, fraternity and sorority life community, etc.)

Fine: Monetary payment

Policy Revision/Creation: Requirement to revise or create a chapter policy.

Restriction: Imposing limitations on activities or participation in campus, chapter, and/or Panhellenic events, etc.

Requirements: Additional conditions or sanctions required of the chapter.

Alcohol Policy Violation: These violations are listed in the Alcohol/Substance abuse policy. (i.e. alcohol on chapter property.)

Social Registration Violation: These violations are provided in Article X of the Panhellenic Bylaws. (i.e. not submitting guest lists, not submitting third party vendor verification, submitting paperwork for social events in a timeline, etc.)

Recruitment Logistical Violation: These violations are in regards to the logistical items associated with sorority formal recruitment. For our purposes, "Recruitment Logistical Violation" includes; late lists, tangible items being taken from recruiting area, inappropriate work week clothing, event length violations, chapter check infraction, and No Frills policy violations

Recruitment Communication with PNM Violation: These violations are in regards to communication that is inappropriate with a potential new member (PNM). For our purposes, "Recruitment Communication with PNM Violation" includes; bid promising, inappropriate alumnae participation in recruitment, contact with a PNM during a period of no contact, conversations with a PNM which made her feel uncomfortable, revealing the identity of a recruitment counselor, inappropriately discussing a PNM's legacy status and recruiting outside of the recruiting area

Recruitment Negative Support Violation: These violation are in regards to any act that does not a positive "Go Greek" of Panhellenic attitude. For our purposes "recruitment Negative Suppose Violation" includes; not promoting a positive PHA spirit, sharing disparaging remarks about another chapter and improper promotion of your own chapter.
